Comprehensive & Zoning Meeting

Called to order at 6:00 Pm by Mayor Kim Martin.

- Madaline Ezell (Mississippi Planning & Development) attended to answer zoning regulation questions.
- Community members raised concerns about rebuilding restrictions if property is more than 51% damaged and not in a residential zone. Per Ms. Ezell they would not be able to rebuild and it would be zoned the way the it is marked on the map. Community members also requested information on the how the property would be affected upon the property owner's death, would heirs be allowed to continue a homestead. Ms. Ezell stated that once the grand fathered in member passes away it would be zone according to the map and heirs would not be allowed to remain using it as residential.
- Mayor Martin encouraged residents to mark their homes on the zoning map to reflect residential zoning and expressed her desire to maintain Bentonia's small-town feel.
- Hwy 49 Corridor to be zoned commercial.
